I was very delighted to have your letter of 7th March which arrived a day or two ago, for the translation of which into English I am indebted to the Consul-General for Peru resident in this city, Senor José M. de la Colina.

With all good wishes and hoping that some day not too far ahead I may have the pleasure of meeting you,

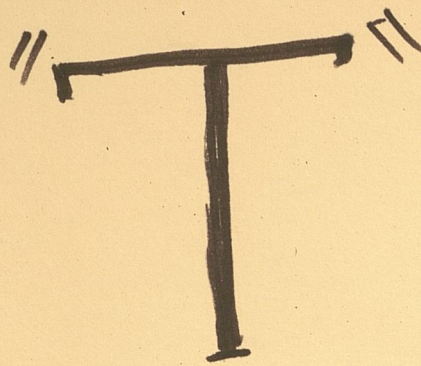
